- 2) If the study is finished please supply the documents that detail the feasibility study. Please advise if non are available yet and the reasons why.
- 3) Please supply minutes of meetings where this study was discussed.
- 4) Please supply the privacy impact assessment (PIA) for having a regional, connected, CCTV system and specifically, which may be included in the general PIA, the privacy impact assessment/s done for the facial recognition element of the system.
- 5) Please advise if the Information Commissioner's Office has been involved in this feasibility study.
- 6) Please advise if the Surveillance Camera Commissioner or his office has been involved in this feasibility study.

Response

The feasibility study into the CCTV platform with automated MISPER detection capability did not take place. The Home Office Innovation Fund bids were designed to cover the cost of a 2 year

feasibility study. Under the Home Office Innovation Fund rules, the first year's funding was lost as it was not claimed within that year. This was due to a number of delays in initiating the work. The Terms of Reference was subsequently redefined with a shorter, 5 month timescale (which ended in March 2018) and the reduced funding supported the exploration of the existing CCTV interoperability across West Yorkshire, known as the West Yorkshire CCTV Interoperability Feasibility Study.

The Office of the Police and Crime Commissioner is therefore unable to provide the information requested.
