Thank you for contacting the Office of the Police & Crime Commissioner with your request for information. You requested the following information:

Please provide details of grants awarded in the financial years 2017-2018 and 2018-2019

- For which at least one of the outputs/outcomes was to provide services to victims of stalking. This could be any service to help victims e.g. counselling, information and advice, casework however there must be specific reference to working with victims of stalking.
- Please provide details of the grant including the amount, the service provider, the services provided and the specific stalking outcome/output.
- Please indicate with a y/n if the service is open to victims of stalking who are not ex-intimate in the table below

Following receipt of your request searches were conducted within the Commissioning Department and the Community Engagement Team.

The table below was provided by our Commissioning team who reviewed our 2017/18 and 2018/19 contracts and grants for all victim related funding.

Unfortunately it has not been possible to ascertain if we hold any information relating to the contracts or grants specifically 'working with victims of stalking' or any restrictions on service as this would involve a manual review of all of the past grant and contract documentation including any performance measures and reporting data to establish if any information is held. It has been calculated that it would take in excess of 18 hours work to establish if this information is held which would cost the OPCC in excess of £450 to comply with these parts of your request. These parts of your requests are therefore exempt under section 12 of the Freedom of Information Act.

The Office of the Police & Crime Commissioner for West Yorkshire allocated £5000 from the Property Act Fund in 2019 to the Suzy Lamplugh Trust to support running the National Stalking Helpline.
